## **President Peter J. Birnbaum Elected To American Land Title Association(R) 2009-2010 Board Of Governors**

Birnbaum has served as president and chief executive officer of ATG since 1991. He currently oversees a staff of 165 people and annual revenues in excess of \$30 million.

With more than 28 years of experience in the real estate industry, Birnbaum is a highly regarded member of the legal and real estate communities.

Birnbaum is a sought-after speaker and has been featured in dozens of regional and national newspapers, trade publications and TV interviews. He has testified in the U.S. Congress, the Illinois Senate and the Illinois Supreme Court Rules Committee.

A judge in the Illinois Court of Claims since 2004, Birnbaum has also held leadership positions on various corporate and philanthropic boards including the presidency of Big Brothers Big Sisters of Metropolitan Chicago. He currently serves on the Jesse White Tumblers Foundation and the Board of Overseers of Chicago-Kent College of Law.

Birnbaum began his career at ATG as a law clerk in 1981, while a first-year student at the Chicago Kent College of Law (where he graduated from in 1983). He advanced to positions of staff attorney, and vice president and counsel. He earned a Bachelor of Arts degree from the University of Iowa in 1979.
