To celebrate the occasion, ATG presented the Thompson family and Mr. Fiocchi with gifts to celebrate the occasion.

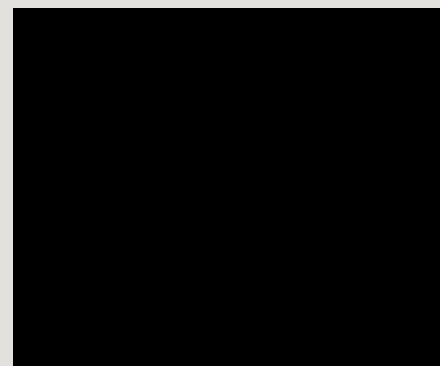
